- I/we understand that Admission and Supply Fees are NON-REFUNDABLE.
- I/we understand that Supply Fees is payable by cheque with registration.
- I/we understand that the registration will be incomplete until all registration forms are complete and handed in the school office; **Admission Fee (new students only) and Supply Fee are paid, otherwise the spot for my child is not guaranteed.**
- I/we/we understand that tuition fees shall be paid by 10 preauthorized electronic withdrawals made on the 10th of each month commencing **August 2019 until May 2020.**
